Ní raibh na pleananna curaclaim sna trí ábhar seo ag teacht leis na treoracha do chur i bhfeidhm na sonraíochtaí sna hábhair mar chuid de *Creat don* tSraith Shóisearach 2015. Cuir i gcás, ní raibh na pleananna leagtha amach de réir aonaid foghlama agus bhí na snáitheanna sna trí ábhar in easnamh san obair phleanála. Is den riachtanas é an cleachtas seo a athbhreithniú.

Ba chóir na straitéisí idirdhealaithe agus idirghníomhaíochtaí a bhí in uachtar i bhformhór na gceachtanna a leathnú ar mhaithe le forbairt suntasach a dhéanamh ar theagasc agus foghlaim sa scoil trí chéile.

Dul chun cinn maith

San idirphlé le múinteoirí ar an moladh seo, ba léir dul chun cinn maith a bheith déanta ina fhorfheidhmiú. Inspectors also advise the school on strategies and actions to enable them to fully address recommendations.

The curriculum plans for these three subjects did not conform to the instructions for the implementation of subject specifications as part of the *Framework for Junior Cycle, 2015*. For example, the plans were not organised in learning units and the strands which pertain to each of the three subjects were not included in the planning work. This planning practice needs to be reviewed.

The differentiated and active strategies which were the primary methodologies employed in the majority of lessons should be used more widely to significantly develop teaching and learning throughout the school.

Good progress

In dialogue with teachers with regard to this recommendation, it was clear that good progress had been made in its implementation. Teaching and learning methods are discussed at staff meetings each week. Continuing professional development was provided in the use of strategies for assessment for learning and differentiation. Cross-curricular peer observation has commenced recently in some subjects in order to share active teaching and learning methods. It would be very worthwhile extending this approach to all subjects.

Steps should be taken to promote Guidance and school self-evaluation (SSE) on a whole-school basis and to implement and review school improvement plans (SIP).

Partial progress

It was reported that there had been an improvement in whole-school awareness of Guidance.

As part of the planning process for the GSRS, a whole-school approach has been developed in order to improve student proficiency in the accurate use of Irish. While good literacy strategies are set out in the subject plan for Irish, there was no evidence that the six-step SSE process was being used to manage action planning in this area on a whole-school basis.

Summary of findings

- An improvement action plan has been developed to achieve recognition as a Gaeltacht school, however the six-step school self-evaluation (SSE) process is not being used to agree and implement improvement targets in all language-based criteria.
- The areas of responsibility of senior management and other school leaders have not been aligned to manage the systematic implementation of the GSRS plan.
- While good progress has been made in developing and sharing teaching and learning methodologies, the high-quality practices evident in over half of the curriculum plans have not been shared with all subject departments.

Recommendations

- Using the six-step SSE process, a GSRS action plan should be developed in consultation with all school stakeholders; this will support the development and systematic implementation of the plan to achieve recognition as a Gaeltacht school over a defined period of time.
- The leadership roles of senior management and other leaders in the implementation and review of the GSRS plan need to be identified.
- Curriculum plans should be kept up-to-date, especially in the context of the approaches proposed in the Junior Cycle for Teachers (JCT) in order to support the implementation of subject specifications.

The board of management of Coláiste Naomh Éinne welcomes this report. The school community is satisfied that the report acknowledges the progress being achieved by the school. The recommendations made are very helpful and the school partners are committed to implementing them.

Part B: Follow-up actions planned or undertaken since the completion of the inspection activity to implement the findings and recommendations of the inspection.

Progress has been made in relation to the GSRS plan, and the use of the self-evaluation process is central to our planning to achieve recognition as a Gaeltacht school.

Leadership roles that support the implementation of the plan have been developed.

Best practice pertaining to teaching, learning and curriculum planning is shared at staff meetings.

Teachers are motivated and supported to engage with continuing professional development and this involvement is reviewed at staff meetings and during probation with newly-qualified teachers.
