The board of management of the school was given an opportunity to comment on the findings and recommendations of the report; the board chose to accept the report without response.

2. All teachers visited reported that they have read the school's Child Safeguarding Statement and that they are aware of their responsibilities as mandated persons
3. The school's Child Safeguarding Statement has been ratified by the board and includes an annual review and a risk assessment.

The school met the requirements in relation to each of the checks above.

<p>Oral Irish should be strengthened in the school and a plan for the explicit development of reading and writing skills should be devised and implemented on a whole-school basis.</p>	<p>Good progress</p> <p>A plan has been devised to develop oral Irish throughout the school and regular instructions have been given to teachers on effective practice in the teaching of Irish during staff meetings and during visits from experts with the support services. A period for oral Irish is compulsory on each timetable but there was a lack of speaking opportunities during lessons observed during the visit. Teachers report on oral Irish in the monthly account and measures are used to encourage pupils to use Irish throughout the school. <i>First Steps</i> is in use for writing and reading and a plan and guides for skills and genres have been devised, although practice in English is stronger in some of the rooms visited, and in the displays in the school. New approaches are in place for Irish and English reading. Groups of varying ability levels are used in certain classes but additional support and increased emphasis on the relevant explicit skills would help the effectiveness of these approaches. Investment was made in appropriate books.</p>
<p>Teachers should have higher expectations for pupil achievement and employ various methodologies, collaborative learning activities and differentiated strategies to cater for the various abilities.</p>	<p>Good progress</p> <p>A language plan for Irish has been devised, although systematic, ambitious development has not been clearly outlined for each theme, throughout the school. Ability groups are used for reading in the lower classes, although the organisation of these sessions merit</p>

	<p>reflection. Continuing professional development was provided for teachers through visits from experts with the support services, focussing on learning activities. Differentiation in the class is reported upon in the monthly accounts. The same genre is covered in English and Irish writing, although expectations are higher for English, and more opportunities in English can be seen in the pupils' work.</p>
<p>The whole-school provision for the additional support for pupils with Special Educational Needs (SEN) should be reviewed.</p>	<p>Partial progress</p> <p>The system in place in the school for organising additional support for pupils with special educational needs has been reviewed. Support is now provided for Irish and a system with three stages and support levels is in place, based on the National Educational Psychological Service's Support Continuum. Many of the support plans and individual plans are shared on the school network. One of the support teachers is being used as a class teachers for this school year and, therefore, there is insufficient time available for pupils with special educational needs. The correct deployment of each special education teacher would improve the level of provision for pupils with special educational needs.</p>
<p>In order to enhance the good work done up to now in school development, it is recommended that ways of strengthening curricular leadership be explored.</p>	<p>Good progress</p> <p>Members of the management team take on various duties associated with curricular leadership. Teachers who attend courses have the opportunity to share the new information that they have at staff meetings. Self-evaluation is not widely used to monitor progress or development as a result of various projects.</p>
<p>Summary of findings</p>	
<ul style="list-style-type: none"> • Good progress has been made on the recommendation regarding the strengthening of oral Irish and the implementation of a plan for the systematic development of explicit reading and writing skills on a whole-school basis, although various aspects still require development. • Good progress has been made on the recommendation which dealt with the use of a variety of teaching methods, cooperative learning activities and differentiation strategies to cater for the different abilities. • Partial progress has been made regarding the review of the whole-school provision for additional support for pupils with SEN. • Good progress has been made on the recommendation regarding the strengthening of curricular leadership. 	
<p>Recommendations</p>	
<ul style="list-style-type: none"> • It is recommended that additional support be provided for teachers when organising reading groups, and that a plan be devised to clearly outline the appropriate reading skills for each level. • The language plan should be reviewed to ensure a systematic approach to language development and realistic, ambitious expectations regarding pupils' progress and attainment. 	

- Each special education teacher should be used to cater for pupils with special educational needs, and as outlined in Circular 13/2017.
- It is recommended that curricular leadership be developed on an ongoing basis among the entire staff and that the school self-evaluation process be used to assess the benefit of various projects.
